# MOTION TO ENTER INTO EXECUTIVE SESSION FOR THE PURPOSES OF:

**A:** Pursuant to Ohio Revised Code Section 121.22(G)(8) for the purpose of considering confidential information related to the marketing plans, specific business strategy, and trade secrets of an applicant for economic development assistance that is to be provided or administered pursuant to O.R.C.
