 - a. Switch from Waste Management (\$630.18/month) to Havenar Waste Removal (ex-firefighters, \$95/month) for a savings of \$6,422.16 (\$7562.16 vs \$1140)
 - b. Discontinue rental of acetylene and/or oxygen tanks from AirGas for Road Dept for a savings of \$106.77/month or \$1281.24/year
 - c. Received a check from Cintas for \$102.85 for mats that we did not have but were being billed over the last 3 years. In addition, purchased our own mats (\$432.47) and cancelled the service (savings of \$1,248/year).

MOTION TO ENTER INTO EXECUTIVE SESSION

- Pursuant to Ohio Revised Code Section 121.22(G)(1) to consider the appointment, employment, dismissal, discipline, promotion, demotion, or compensation
 of a public employee or official, or the investigation of charges or complaints against a public employee, official, licensee, or regulated individual, unless the
 public employee, official, licensee, or regulated individual requests a public hearing. Except as otherwise provided by law, no public body shall hold an
 executive session for the discipline of an elected official for conduct related to the performance of the elected official's official duties or for the elected
 official's removal from office.
- 2. Pursuant to Ohio Revised Code Section 121.22(G)(8) To consider confidential information related to the marketing plans, specific business strategy, production techniques, trade secrets, or personal financial statements of an applicant for economic development assistance, or to negotiations with other political subdivisions respecting requests for economic development assistance, provided that both of the following conditions apply:

(a) The information is directly related to a request for economic development assistance that is to be provided or administered under any provision of Chapter 715., 725., 1724., or 1728. or sections 701.07, 3735.67 to 3735.70, 5709.40 to 5709.43, 5709.61 to 5709.69, 5709.73 to 5709.75, or 5709.77 to 5709.81 of the Revised Code, or that involves public infrastructure improvements or the extension of utility services that are directly related to an economic development project.

(b) A unanimous quorum of the public body determines, by a roll call vote, that the executive session is necessary to protect the interests of the applicant or the possible investment or expenditure of public funds to be made in connection with the economic development project.

If a public body holds an executive session to consider any of the matters listed in divisions (G)(2) to (8) of this section, the motion and vote to hold that executive session shall state which one or more of the approved matters listed in those divisions are to be considered at the executive session.

A RESOLUTION AUTHORIZING A SUPPLEMENTAL APPROPRIATION OF \$207,460 TO THE 2025 PERMANENT APPROPRIATIONS TO BE USED TO CONSTRUCT A SHELTER & PICKLEBALL COURTS AT FRIENDSHIP PARK

The Bethel Township Board of Trustees, Bethel Township, Miami County, Ohio met in regular session on the 4th day of June, 2025 with the following Trustees being present: Kama Dick, Julie Reese, and Beth vanHaaren.

Trustee **moved for the adoption** of the following resolution:

WHEREAS, the residents of Bethel Township do not have a shelter space at Friendship Park; AND

WHEREAS, the Trustees believe that there need to be more options for community activities for Township citizens; AND

WHEREAS, the Township has applied for a grant to partially pay for a combination shelter and two pickleball courts; AND

WHEREAS, this will require a supplemental appropriation of \$207,460 and the Board of Trustees must approve the supplemental appropriation. **THEREFORE**

BE IT RESOLVED, that the Board of Trustees of Bethel Township, Miami County, approves the supplemental appropriation of two hundred seven thousand four hundred and sixty dollars and zero cents (\$207,460.00) into the General-Capital Outlay-Buildings-Friendship Park Shelter/Courts account number 1000-760-720-3810 to be solely used to construct a shelter house with two pickleball courts at Friendship Park.
