New Comprehensive Land Use Plan Approved

At the November 30, 2010 meeting of the Bethel Township Board of Trustees, the Board passed Resolution #10-11-159 adopting a new Comprehensive Land Use Plan for the Township. As required by law, this new Plan has been forwarded onto the Miami County Commissioners for their approval, as an amendment to the Miami County Comprehensive Land Use Plan. The passage of this resolution represented the culmination of a two year process that the township undertook to revise the 2005 Strategic Development Plan (SDP). The Board of Trustees recognized many deficiencies with that Plan. During the initial phase of updating that Plan, the Township worked with the same consulting firm that had participated with the plan's initial development. In 2009, the Township presented to residents, via public input meetings, a concept to address changes to the US Route 40 corridor area of the SDP. It was apparent the ideas did not parallel the input of the public and did not address the remainder of the Township. The Trustees decided to refocus on developing an overall update for the entire Township rather than focusing on just the Route 40 corridor area. This update was directed by an appointed steering committee of interested Bethel residents and assisted entirely by Township staff rather than hiring a consulting firm. One of the first decisions the steering committee made was to rename the SDP to reflect its intent. Their decision was to change the name to the Bethel Township Comprehensive Land Use Plan.

The plan calls for eight planning areas and six basic land use types:

Planning Areas

Rural Traditional Neighborhood Office/ Residential Commercial Industrial Rural Settlement Public/ Semi Public Flood Plain

Land Use Types

Agricultural Residential Office Commercial Industrial Public Use

The plan places an emphasis on Conservation Development, which recognizes the protection of property rights of the owner, while preserving the rural character of Bethel Township. Other elements of the plan addressed are Annexation Issues, Township Services, Infrastructure, Sewer/Water, On-Site Decentralized Wastewater Treatment Systems, Roadways, and Bike Paths.

The Board of Trustees would like to recognize the diligent and dedicated work of the Comprehensive Land Use Steering Committee members, the members of the SDP Route 40 Corridor Update Steering Committee, as well as Township staff; Planning & Zoning Director, Andy Ehrhart and Township Administrator, Mike Gebhart.

Zoning Update

Bethel Township Zoning Commission (ZC):

The Zoning Commission met in regular session on October 28, 2010 to hear the following cases:

- <u>Case #ZA-05-10:</u> A request by the Bethel Township Trustees to review and revise Article 30 of the Bethel Township Zoning Resolution. Approved
- <u>Case #ZA-06-10:</u> A request by the Bethel Township Trustees to review and act upon The Bethel Township Comprehensive Land Use Plan. Approved
- Case #ZA-07-10: A request by Nancy Minor, 602 Farrell Rd, Vandalia, Ohio, to rezone and subdivide the parcel located at 7135 Singer Rd. The parcel is currently zoned A-2, the request is to rezone to a combination of R-1AAA and A-1. The property in question is located on the north side of Singer Road approximately 2900 feet east of the intersection of Singer Road and State Route 201. Approved

The Board of Zoning Appeals (BZA) met in regular session on October 28, 2010 to hear the following cases:

- <u>CU-02-10:</u> A request from Charles Caudy, 6480 Elizabeth Bethel Road, Tipp City, OH. The applicant requests conditional use approval to utilize an existing accessory building for the storage of Recreational Vehicles and Boats on property zoned Agricultural (A-2). Approved
- <u>V-03-10:</u> A request from Larry & Stephanie Dollar, 6191 Agenbroad Road, Tipp City, OH. The applicant requests a variance to build a 40'x60' accessory structure, totaling 2400 square feet, which is 500 square feet above the maximum allowed of 1900 square feet. Approved
- <u>CU-03-10</u>: A request from Darin & Cynthia Morris, 5485 Ross Road. The applicant is requesting the BZA continue a CONDITIONAL USE under Sec. 15.04 of the Bethel Township Zoning Resolution, to operate Christian Family House, Inc (CFH)-Moto. CFH-Moto would mentor at risk youth in the area. CFH-Moto would operate a motor cross track on site. Approved

From the Fire Department: New Fire Lieutenants Appointed

The Bethel Township Board of Trustee is pleased to announce the selection of five (5) new Lieutenant's for the Township's Fire Department. The new Lieutenant's are Mike Arnold, Matt Bakan, Nick Carpenter, Shawn Cline and Charlie Pacheco. The new Lieutenant's join Lt. James Sebastian, who has served as a Lieutenant with the Department since January of 2007.

Fire Chief Stitzel received twelve (12) applications from current Department member's who wished to serve as Lieutenant's. During late September and early October of 2010, those candidates went through three written examinations covering State of Ohio Level 1 and 2 Firefighter Certification, as well as a Miami Valley EMS Protocol Test, followed by an interview process, and finally a skills assessment simulation. During this simulation, each candidate was given the same structure fire scenario and asked to take command of the incident. Fire Chief Stitzel commented, "I am pleased with the number of quality applicants we have, and how well they all tested. Anyone of these gentlemen would make excellent officers." All fire officer positions are part-time positions.

Today's challenging economic times have forced all of us to make budget related adjustments in our personal and professional lives. We thought we would share a few of the most significant savings with you...

Ohio Workers Compensation Reclassification of Fire/EMS Staff	\$ 79,000.00
Reorganization of the Fire Department Command Structure	\$ 26,000.00
In House Update the Township's Land Use Plan	\$ 60,000.00

Some things are hard to attach a dollar amount to. We are testing a new technique for asphalt repairs. This new process of repairing just the problem section of asphalt rather than a much larger area surrounding the problem section of asphalt could save hundreds of dollars per each repair. Another part of our operation, that is hard to place a dollar amount to, is the cross training of all full-time staff members in Fire/EMS. The Township Administrator, the Planning & Zoning Director and both members of the Road Department not only cover their individual job responsibilities, but also respond as members of the Fire Department on emergencies throughout the Township. Even our elected Fiscal Officer has become cross trained as an EMT-Basic.

With the current economic conditions, budgeting is challenging, but with the help of the Fiscal Officer and the Township Administrator, the Trustees are trying to be proactive. None of this would be possible without the dedicated employees we have at the township. There have been no raises in 2009 and 2010. With that being said, we feel that it is very important to acknowledge our staff's hard work and dedication to provide excellent service to the residents of Bethel Township and we thank them for that.

Zoning Code Update

Bethel Township recently finished up a five month process to update Article 30 – General Regulations of the Zoning Resolution. The process consisted of two workshop meetings with the Zoning Commission and a public hearing with the Zoning Commission, Bethel Twp. Trustees and the Miami County Planning Commission. The changes included areas regulating accessory structures, fences, residential handicap ramps and residential storage of commercial vehicles.

Over the next several months the Township will continue to update areas of the Zoning Resolution. With the recent adoption of the Comprehensive Land Use Plan there will be several areas that will need reviewed to make the Zoning Resolution as efficient as possible.

Help Wanted: Volunteer Boards

Bethel Township currently has openings for several volunteer positions within the township.

- Alternate to Bethel Zoning Commission, one year term.
- Alternate to Bethel Board of Zoning Appeals, one year term.

Time needed for these positions is approximately 2 to 4 hours per month for case preparation—review documents, visit site, review applicable section of zoning code and then one monthly meeting, typically 1 to 2 hours in length. If there are no cases, then the board does not meet.

From the Road Department

As you are reading this, we are right in the middle of the 2010-2011 snow plowing season. The Road Department asks that residents and drivers help us by doing the following:

- 1. Do not place objects near the roadways that could potentially be struck during snow and ice removal.
- 2. Do not pass a snow plow unless absolutely necessary.
- 3. Allow plenty of stopping distance; don't follow the plow trucks too closely. This also reduces the chances of lose material hitting your vehicle.
- 4. Never assume that the snow plow operator can see you. Every truck has blind spots.
- 5. Consider delaying non-essential travel until after the roads have been cleared.
- 6. Keep your head lights on low beam.
- 7. When using a snow blower, shovel or plow to clear your driveway, do not push the snow out into the street. This can create a danger to motorists.
- 8. To avoid clearing your driveway entrance repeatedly, wait until the plow trucks has completed clearing the roadway. Pile snow to the left side of drive as you face your house, specifically when clearing near the road. This will prevent the plow from dragging the snow back across your driveway apron.
