## Miami County's Phoneton Sewer Project

In May, 2011, the Miami County Commissioners were awarded \$5.5 million in Ohio EPA Principal Forgiveness Funding (funding that does not have to be repaid) for the purpose of constructing a gravity sewer system in Phoneton and Wiley Industrial Park and running sewer force mains from Brandt to Phoneton, Phoneton to West Charleston and Brandt to Bethel Schools. The remainder of the project costs are eligible for an Ohio EPA 0% Interest Loan.



This project is important to Miami County and Bethel Township for several reasons:

- Elimination of a health hazard: Most of the homes and businesses in Phoneton and Wiley Industrial Park are served with private wells and on-site wastewater treatment systems. On-Site wastewater treatment systems in this area mostly consist of septic tanks with leach fields; and several discharging systems, which is no longer a currently approved method of septic waste disposal. Most of the leach fields are smaller and older (30 years +) than what would be permitted under current OEPA or County Health Standards. Finally, most of the lots have insufficient available space for a replacement system to be constructed. The County Health District has quite a bit of well sampling information for this area that has been collected over the years. Approximately 50% of the samples tested positive for fecal coli form, an indication that untreated septic waste could be contaminating private wells.
- <u>Prevent Annexation:</u> The sewer will provide infrastructure that helps to prevent annexation of
  the township to Huber Heights. The wastewater from this project will be treated by Clark
  County via the Brandt Sewers Pump Station.
- <u>Funding:</u> The project is largely funded by the Ohio EPA. The county and the township could not afford to put this infrastructure in place without the grant from this agency.
- <u>Increase Property Values:</u> Centralized sewer can increase both residential and industrial property values.
- <u>Supports Bethel Township businesses:</u> Centralized sewer allows businesses to grow (both in people and in building size) without having to put in additional septic tanks and leach beds.

The Phoneton Sewer project has been split into five separate construction contracts. These five contracts were awarded by the Miami County Commissioners in early December to three different contractors. Fifteen different companies bid on all or some of the contracts in October. Construction will begin in spring of 2012, although you may see surveying and pre-construction crews out in January and February. Phoneton residents, Wiley Industrial Park, Process Equipment Company and Bethel Schools can expect to begin to connect to the sewer in 2013.

#### Miami County's Brandt Sewer Project Update

Work continues to progress on the Brandt Sewer Project. The gravity portion of the sewer in Brandt is in the final phase of pipe testing. Crews are working to complete the gravity lines east of US40 and SR201 and the pump station located to the east of Brandt on US40.

Miami County Sanitary Engineering anticipates that hook ups from the sewer lines to each residence will begin sometime during the first three months of this year.

- Keep all access doors locked along with vehicle doors
- Keep an extra car in the driveway close to the house in a well lit area instead of in the garage to make it appear someone is home
- Leave a radio on and make the house appear occupied
- If anyone knocks at your door and then has an unreasonable explanation for being there, i.e. "do you know where so and so lives", "can I use your phone", "I ran out of gas", etc. please obtain a license plate number and description of vehicle and call 911 immediately. Many daytime burglars will ring or knock first prior to breaking in to make sure no one is home. If someone answers the door they will be nervous and have an unusual reason for being there. The same goes with calls or hang-up calls. Burglars do not want you to be home when they break-in and will try to make sure no one is home.
- Learn what cars belong at your neighbors and call 911 if any vehicle not seen before is noticed in the driveway. Rural burglars will target those residences that have few neighbors so please look out for any unusual vehicle and call 911 immediately.
- Keep all valuables inside your residence; do not leave them in the car. At night, park car in garage if possible or close to residence in a well lit area.
- At nighttime utilize exterior lighting around your house to deter crime. If you get up in the middle of the night, take a moment to look out your window to observe any persons or vehicles that may be prowling.

In order to help solve State funding shortfalls, the State Legislature in August of 2010 reduced the Ohio Local Government Fund, to every township, village, city and county in Ohio by 25 percent for 2011 and will further reduce that funding by another 50% for 2012. Prior to this decision by the Legislature, Bethel Township received approximately \$51,000.00 in Ohio Local Government Funds each year. For 2011, Local Government Funding was reduced to Bethel Township to approximately \$38,250.00 and for 2012 it will be reduced further to \$19,125.00.

In addition to the cuts to the Ohio Local Government Fund, the State legislature has also eliminated all estate taxes by 2013. Both of these funding sources helped offset the cost of services provided to residents not only in Bethel Township, but to communities across the State.

Gasoline tax revenue continues to shrink as the slow economy has reduced consumption, and thus collection of the State gasoline taxes. By formula, these taxes are distributed to Local Governmental units on the bases of the percentage of road mileage they are responsible for maintaining. In Bethel Township, we are responsible for roughly 1/3 of the 77 miles of roadway in the Township.

An ironic element of our state tax structure is that local government, the most responsive form of government, is the only level of government, that we directly approve the taxes for. Township Government cannot levy a tax to support general services without you, the voter, directly approving it. Townships and School Districts rely on you the tax payer for support, and we as local officials appreciate that support. The Township has several voter supported levies, which fund Township services based on your property tax. The Fire and Emergency Medical Services are funded by two levies; one of 1.5 mils and one of 2.0 mils. Additional Police Protection is provided by a contract with the Miami County Sheriff funded by a levy of 1.0 mil. The 3.8 mil, approved in 2003 and renewed in 2008, supports our efforts to protect the viability of the Township. These funds have been reserved to only fund efforts to protect our boundaries, and thus protect our long-term financial security and preserve our Bethel Community and lifestyle.

In two ways, the weak economy directly influences our revenue stream from these property value based taxes. Unfortunately, our community has not been spared from the property value losses that are occurring throughout the country. This leads to a long term decrease in lower tax revenue. In addition to lower property values, the downturn in residential and commercial growth limits any new revenue being generated to help offset those losses.

We are committed to be fiscally responsible cutting costs, whenever possible, while maintaining acceptable services.
