# **Funding of Bethel Township Government**

Like all governmental units, funding of services remains tight. In the last few years the weakness of the general economy has put stress on the budgets of every level of government. Townships do not rely on income taxes for support nor do Townships have the authority by state law to impose an income tax to support our services like municipalities. Bethel Township relies on 0.9 mills of *inside statutory un-voted millage* levied on real-estate in the unincorporated area of the township and the millage you as voters entrust us to levy.

You, the voters of Bethel Township, are currently supporting your local governmental services through four separate levies:

- A permanent -1.0 mill levy for Additional Police Protection which funds a contract with the Miami County Sheriff
- A 5yr 2.0 mill levy for Fire and EMS Services
- A permanent -1.5 mill levy for Fire and EMS Services
- A 5yr 3.8 mill Levy for General Fund Support

The 3.8 mill General Fund Levy began in 2004 and was renewed for an additional five years in 2008. The intent of the 3.8 mill levy was to fight annexation and preserve the Bethel Community as our residents recognized it. Through frugal fiscal responsibility we have utilized these funds to develop a Comprehensive Land Use Plan as well as for engineering studies for water and sanitary sewer service to areas of the township which have known health concerns or are susceptible to the threat of annexation without proper infrastructure. Funds have also been used to offset the cost of assessments to Residents of the Brandt Sewer Project as well as to expand the Phoneton Sewer Project to serve Bethel Local Schools. We also anticipate additional support of the Phoneton Sewer Project. We continue to pledge appropriating those funds to preserve the integrity of the township and discourage any potential future annexations.

While our revenue from real estate taxes has remained relatively stable during the down turn of the economy, our funding has significantly shrunk with the elimination of the State Inheritance Tax in 2013 and continuing reduction of the State Local Government Funds. The township's only other tax revenue is a portion of the State Gasoline and Motor Vehicle License Taxes, which are designated for the repair and maintenance of township roads.

We have been able to stretch your tax dollars, across the entire scope of each fund. In this environment of shrinking tax revenue we have sharpened our pencils by:

- Consolidating job responsibilities taking advantage of attrition to cut personnel costs.
- Loaning from the un-encumbered funds of the 3.8 mill levy to purchase new Fire truck in 2011 rather than financing the purchase with a conventional loan. Thus saving additional cost of interest from the fire fund. With the current economic conditions un-encumbered funds are not accruing significant interest income.
- Applying for and receiving various grants for specific projects and programs.

Bethel Township continues to strive to give the most efficient government services possible and encourage you to attend our meetings and offer your input. The trustees meet in regular session on the second and fourth Tuesday every month at 7:00pm.

## Long Driveway Identification

Long driveways in Bethel Township present a unique challenge for the Fire Department. Our fire engine has 1000' of large diameter hose. We use this hose to supply water to our fire engines. In an effort to improve our pre-planning process and provide better services to our citizens, we want to identify driveways longer than 1000' so that in the event of a fire, we have the appropriate amount of hose and can more efficiently stage the engines and the water truck. If your driveway is longer than 1000' please contact Lt. Rich Morrett at 845-4274. The Fire Department will place a reflective sticker on your mailbox as well as marking a spot on the driveway 1000' from your house. If you think your driveway is close to 1000' but not sure, please call and the Fire Department will come and measure it for you.
