Roads, Potholes and Repaving

Bethel Township maintains a little more than twenty five (25) miles of roadway. The responsibilities include pavement repair, resurfacing, roadside mowing, culvert maintenance and replacement, overhanging tree trimming, snow/ice removal, and berm maintenance. The township employs one full time road worker and several part time seasonal road workers. The money to pay for equipment, materials, salaries, fuel, repairs, maintenance, road improvements, salaries and other expenses comes from four funds, which combined in 2014, generated \$249,000. The funds are:

\$249,000 sounds like a lot of money, until you realize the cost of maintaining and /or replacing road equipment, factor in the increases in fuel, salaries, vehicle insurance, workmen's comp insurance and add to that the ever increasing cost of asphalt and salt. In 2014, the township committed to an extremely frugal road department budget: we did no major paving projects or crack sealing, no equipment purchases, no culvert or ditch restoration, limited tree trimming and reduced roadside mowing. The result - the township spent \$145,000 in 2014 on road and bridge items. This allowed us to save \$104,000, which will be spent this year on repaving Scarff Road from 571 to New Carlisle Road. The current cost for re-surfacing is approximately \$110,000 per mile of roadway. A good overlay can extend the life of a road 15—20 years. For 2015 and 2016, our goal is to save \$40,000 each year to build up enough reserve to once again have enough money to repave another mile of township road.

This method of "save and repave" works fairly well until we need to replace a dump truck, a lawnmower or a snowplow. Our road department vehicles are aging. We do as much maintenance as possible in house. However, ageing vehicles generally require more frequent and more costly maintenance. Below is a chart of our equipment and current replacement costs:

In addition, there have been no raises in salary for the road department workers since 2008. There are other items, which despite all frugal measures, will always be fairly fixed costs: fuel (\$21,000), salt (\$10,200), workmen's comp insurance (\$3,500) and equipment liability insurance (\$3,000) (all costs are from 2014). These items are necessary to keep our roads, township residents and our workers safe. The value of the four funds listed above has been fairly steady over the past 5 years, thus even as fixed costs increase, the funds do not increase.

Frugal spending combined with conservative estimating suggest that the township, with current funding, could repave one mile of road approximately every four years. This makes the "paving cycle" for all 25 miles possible only every 100 years. Clearly, this is not an acceptable option. Chip and seal is a much less expensive solution, costing approximately \$25,000 per mile. However it needs time to be worked into the road and many residents do not like the "chip" that goes flying during the work in period. Chip and seal can extend the life of a road 5—7 years but it would still require an overlay at the end of this life span.

You may wonder - why not use general fund money? Or 3.8 mil Levy money? Several sources of general fund money to all Ohio townships have been reduced or eliminated in the past few years. In prior years, the township received monies from the estate tax, the personal property tax, and the local government fund. Most of this funding is no longer available, eliminating over \$192,000 in township annual revenue that was used for fuel, vehicle maintenance, road department salaries, building repair, insurance and other things. The original intent of the 3.8 mil Levy money was for infrastructure improvements to fight annexation. As stewards of this levy, the trustees feel that it is vitally important to continue to spend the funds in a manner that is consistent with the original goal. To date, we have used 3.8 mil levy funds on two road projects that were a result of infrastructure improvements: repaving Brandt streets and Wiley Industrial Park streets after the sewer line installation.

This November, a 2.1 mil Road & Bridge Levy will be on the ballot. This is a *new* levy. Bethel Township currently does not have any road levies. The funds from this levy can only be used for road maintenance, repairs and equipment, such as those previously mentioned. It will cost a homeowner \$73.50 per year for a \$100,000 home, or \$0.20 per day. It will generate \$280,266 annually. This will allow us to repave roads on a 15 year cycle, rather than 100 years and maintain and replace our equipment in a conservative manner without having to borrow money. The trustees are very conscious of the need to keep taxes as low as possible. Every effort is made to reduce costs and to keep ex-

penses at a minimum. With the substantial loss of annual tax revenue to the general fund (both state and local) over the last few years, combined with the increase in asphalt, salt, insurance, salaries, vehicle and fuel costs, we feel a 2.1 mil Road & Bridge Levy is the best solu-

Smoke Detectors and Carbon Monoxide Alarms

Bethel Township Fire Department received a \$300 grant to purchase smoke detectors and carbon monoxide alarms. If you are a township resident, please call the Fire Station at 937-845-4274 and ask for Lt Rich Morrett. They will come out and inspect your current detector's and if needed, provide you with a new one. The Fire Department will install the units for you at no charge and/or change the batteries on your existing units. These smoke detectors use photoelectric sensors. The International Association of Firefighters recommend the use of photoelectric smoke alarms. This type of smoke detector is is far less likely to sound nuisance alarms and, as a consequence, is less likely to be disabled.
