The BZA meets on the fourth Thursday of the month at 6:30 p.m. in the Bethel Township Meeting Room. Additionally, residents within 300' of the requesting property are notified by first class mail as per the Bethel Township Zoning Resolution and the Ohio Revised Code.

### **Winter Road Tips**

The winter months are upon us and bring with them the challenges of driving in conditions that are not easy on anyone. The Bethel Township Road Department will make every effort to keep roadways as safe as possible for the traveling public during times of snow and ice. The township purchases the road salt from Miami County. This year, Miami County is mixing all the road salt with grit, which will stretch the supply of salt but is not as effective at melting the ice on the roadways. As always, please use caution when driving in icy and snowy conditions.

#### Plowing responsibilities

The Bethel Township Road Department maintains approximately 26 miles of the 75 miles of roadway within the township. Other government agencies or private concerns maintain the other 49 miles.

- The Ohio Department of Transportation (937) 339-1921 maintains all state routes: 201, 202, 40 and 571.
- The Miami County Engineer's Office (937) 440-5656 maintains County roads: Studebaker, Rudy, Ross, Scarff (north of New Carlisle Road), Palmer and Dayton-Brandt
- Mobile home parks have streets maintained by the owners of the park.
- Private drives and lanes are not maintained by the Township.

## Recycling

Many township residents are making good use of the township recycling bins, located to the west of the Fire Station in Brandt. The bins are generally emptied on Tuesday and Friday afternoons. Below is a list of acceptable recycling material:

- Plastics, 1-7
- Aluminum Cans & Aluminum Foil
- Metal Cans—soup cans, vegetable cans
- Paper—office paper, magazines, flyers, phone books, newspaper
- Cardboard—corrugated boxes, food boxes. Please make sure there is no food waste on the cardboard—ie NO PIZZA BOXES!

#### Currently our current recycling vendor, Waste Management, does not accept glass for recycling.

The township has a separate green bin, labeled "GLASS" for residents to use. We take the glass to the county recycling station in Troy. If you have any questions on the type of glass that can be accepted, please contact the township at 845.8472. Thank you for helping Bethel Township do its part for the environment.

#### Not all glass can be recycled. Below is a list of items that should NOT be placed in the recycling bin:

- Mirror or Window glass
- Crystal
- Plastic or metal lids

- Heat resistant glass, such as Pyrex
- Any glass contaminated w/stones, dirt or food waste
- Ceramics dishware, bakeware and decorative items

#### **Recycling Facts:**

- Recycling a pound of steel saves enough energy to light a 60-watt light bulb for 26 hours.
- Americans recycle only 5% of all the plastics produced in this country.
