Hospital Choices

Bethel Township Fire Department responds to over 400 emergency medical service (EMS) calls per year. Frequently, the patient needs to be transported to a medical facility. Bethel Township crews will offer a wide range of choices on where to go. We transport to:

Upper Valley Good Samaritan Miami Valley

Huber Heights Emergency Springfield Regional Medical Wright Patterson Air Force

Room Center Base

Grandview Children's Medical Center Soin Medical Center

Other hospitals such as Kettering Medical Center or Southview Hospital are too far away for our crews to make a quick turn around and get back to protect the Township. For example, a trip to Kettering would take over an hour and half for our crews to return for the next emergency, whereas a trip to Grandview would be under an hour. In addition to the distance, we have to pass other hospitals (including ones in the same network) to reach those destinations. In an effort to provide maximum coverage to the entire township, it is important for the crews to deliver the patient to the most appropriate hospital in a timely manner. Hospitals in the Premier Network are Miami Valley, Upper Valley and Good Samaritan. Hospitals in the Kettering Network are Grandview, Soin and Huber Heights ER. Springfield, Wright Patt AFB and Children's are not in any other networks.

There are also times when the emergency dictates where we take patients. Examples of this include trauma, stroke, burns, and other critical emergencies. We are dictated by our "protocols" to take patients to specified hospitals that are specifically equipped to handle these emergencies. It is also possible that at times emergency rooms close due to high volume; this is called rerouting. We are notified by our dispatch when an ER is closed and we are not able to take patients there.

If you have the medic come to your house and the crews tell you that you or a loved one cannot be transported to your hospital of choice, please realize that they are following policy that has been created to ensure the best possible care for the patient and also provide the highest level of service for the residents of the township. Phoneton Water Project

Using 3.8 mil Levy money, the Bethel Township Trustees have entered into a contract with Miami County Commissioners and Access Engineering to undertake the design, engineering and construction of a waterline extension from Brandt to Phoneton. The project will run along US Rte 40, south on SR 202 and Wildcat to connect with Wiley Industrial Park, through Dinsmore and Shroyer and north a short distance on SR 202. Bethel Township was awarded a \$400,000 grant from the Ohio Public Works Commission (OPWC) for this project and a \$200,000 0% interest loan which will offset some of the costs of this project. As the design and engineering phase is completed in June, more detailed information will be available.

The Bethel Township Zoning Commission (ZC) did not meet for the month of January. The Bethel Township Zoning Commission (ZC) did meet in February to for a workshop session to review the zoning code with the BZA. The Bethel Township Zoning Commission (ZC) did meet in March to hear the following case:

<u>Case ZA-01-15:</u> A request from Don Caldwell of 8430 Flick Road to rezone the property located as Miami county parcel ID number A01-071100 on SR 571 from A-2 General Agriculture to A-1 Domestic Agriculture to allow for lot split on ground used for residential and agricultural purposes. **Passed 5-0**

BETHEL TOWNSHIP BOARD OF ZONING APPEALS (BZA):

The Bethel Township Board of Zoning Appeals (BZA) did not meet in January due to the applicant cancelling the variance request:

Case V-01-15: A request from Javier Perez of 8455 Overlook Dr. New Carlisle, Ohio, 45344. The applicant requests a variance to put an accessory structure in the front yard and decrease the side yard setback for an accessory building from the required ten (10) feet to approximately three (3) feet. The property is identified at Miami County Parcel ID # A01-027560. Cancelled

The Bethel Township Board of Zoning Appeals (BZA) did meet for the month of February for a workshop to discuss zoning code updates with the ZC. The Bethel Township Board of Zoning Appeals (BZA) did meet in March to hear the following case:

Case V-02-15: A request from Tracy Watson, 968 Bellefontaine RD, New Carlisle Ohio 45344. The applicant requests a variance to increase the maximum size of permitted accessory structure from the required Sixteen Hundred (1600) square feet to approximately Three Thousand Five Hundred (3500) square feet. The property is identified at Miami County Parcel ID # A03-004800. Passed 3-1

The BZA meets on the fourth Thursday of the month at 6:30 p.m. in the Bethel Township Meeting Room. The Zoning Commission meets on the fourth Thursday of the month @ 7:30 p.m. in the Bethel Township Meeting Room. Public notice for both the Zoning Commission and the Board of Zoning Appeals meetings are posted in the news section of the Township web site at www.betheltownship.org, and in the Troy Daily News. Additionally, residents within 300' of the requesting property are notified by first class mail as per the Bethel Township Zoning Resolution and the Ohio Revised Code.

Bethel Local Schools 0.75% Earned Income Tax RENEWAL

On May 5th, Bethel School District voters will have the opportunity to vote on the renewal of a 0.75% Earned Income Tax (EIT). First passed by voters in 2010, this EIT generates approximately \$1.2 million which makes up almost 14% of Bethel Local Schools' budget. Presently, the school only receives 3 million dollars from the state to assist with the 9 million dollar budget needed to keep the district running efficiently. And Bethel Local Schools run very efficiently. According to data from the Ohio Department of Education, of the 21 schools in our surrounding community (all schools in Miami County and/or in the Cross County Conference), *only 1 school spends less money per student than Bethel*. The revenues from the Earned Income Tax levy will only grow as the number of residents moving into Bethel School District increases.

The money collected from the EIT touches every area of the district from books and curriculum to fuel and cleaning supplies. It provides students with positive learning environments and the materials needed to grow and succeed on a daily basis. Looking forward, Bethel's Superintendent, Virginia Potter, stated "This renewal money is not about the extras....it's about the necessities! Without it, our teachers will be unable to provide the education our community has come to expect from its schools. Its absence from our budget will only slow down the progress we are making with the district's strategic plan....to educate with excellence and inspire our students to reach their potential in an everchanging global society."

Bethel community members have until Monday, April 6, to register to vote for the NO NEW TAXES renewal on Tuesday, May 5th.
