4.9 mill Fire & EMS Levy on the Ballot in November

Bethel Township Fire Department is funded by a series of dedicated, voter-approved property tax levies. Due to state law, the rate of these levies is reduced over time so that the revenues generated by the levy do not increase as the value of properties increase. Therefore, as the cost of delivering these services increases (personnel, supplies, materials, equipment, etc.), the Township must periodically seek an increase in the approved tax levy.

Voters in the Township last approved additional funding for Fire and EMS in 1999. That was seventeen years ago. In 2015, we went on 560 calls for service and in 2014 we had 592. Our response time for those two years was approximately 90 seconds to get out of our door and on average seven minutes to your door. We are running an important service in 2016 on a paycheck from 1999. In addition to the impact of inflation in the operations of the Fire Department, the overall response activity is steadily growing. This is due to a steady increase in calls for fire, rescue, and emergency medical services (EMS).

In November, you will be asked to vote on a 4.9 mill *replacement* levy with increase. The current levy is 2.0 mills. The Township has always tried to make Fire/EMS levies last as long as possible. If this levy passes, our focus will be on replacing aging equipment and upgrading staffing, allowing us to keep up with the demand. Our current system utilizes a modified volunteer program at night. The rigorous certification, continued training and commitment required to be a firefighter and EMS responder is making it almost impossible to maintain this current "volunteer" system. The passage of this levy would allow the department to staff 24 hours a day/7 days a week with on station part-time employees (our daytime program is already part-time).


In the past seventeen years, funds projected to be generated by the 1999 levy did not completely materialize due to an unanticipated drop in property values, increased delinquencies, and the elimination of tangible personal property taxes. If voters approve this levy request, they will pay an additional \$115.35 per year, or \$9.61 per month, for every \$100,000 of home value. If voters approve the additional levy in 2016, it would not go into effect on tax bills until 2017.

Voting Locations in Bethel Township

Tuesday, November 8th, voters in Bethel Township will head to the polls. The only local issue is the 4.9 Replacement Fire and EMS Levy. Bethel Local Schools has no issues on the ballot. Voting locations:

- **Bethel West and South Central** vote at the new West Charleston Church of the Brethren 4817 SR 202.
- **Bethel South East and East** vote at the First Baptist Church 8870 SR 571.
- **Bethel Huber Heights** votes at the Fire Station in Brandt. This precinct does **not** vote on township issues, but does vote on Bethel School issues.

Winter Plowing Information

The winter months will soon be here and it's hard to believe when the temperatures are still in the 60's. During snow and ice storms, the Bethel Township Road Department makes every effort to keep roadways as safe as possible for drivers. Please note that in an effort to reduce costs, we will not plow between the hours of 1 AM - 5 AM unless storm conditions dictate otherwise.

Plowing Responsibilities

The Bethel Township Road Department maintains approximately 26 miles of the 75 miles of roadway within the township. Other government agencies or private concerns maintain the other 49 miles.

- Bethel Township (937) 845-8472 maintains Sullivan, Ginghamsburg-West Charleston, Newberry, Windham, Flick, Pisgah, Agenbroad, roads in Brandt and Wiley Industrial Park, Mann, Cobaugh, Singer, Haskett, Winterhill, Scarff (south of New Carlisle Road), New Carlisle Road and Heilman.
- The Ohio Department of Transportation (937) 339-1921 maintains all state routes: 201, 202, 40 and 571.
- The Miami County Engineer's Office (937) 440-5656 maintains County roads: Studebaker, Rudy, Ross, Scarff (north of New Carlisle Road), Palmer and Dayton-Brandt.
- Mobile home parks have streets maintained by the owners of the park.

Fire Levy Millage in Surrounding Communities

This November, the Township will be replacing a fire levy on the ballot. The current 2.0 mill levy has been in place since 1999 and has been renewed every five years since then. The 4.9 mill *replacement* with increase levy on the ballot in November will replace the current 2.0 mill levy. It is extremely important to the township and the fire department that we use funds in a fiscally responsible manner. Please take a look at the chart below listing the millage, population and number of runs per year for surrounding communities. As you can see, we currently have the lowest millage but the second highest call volume.

Funds from this levy, if it passes, will pay for replacement of a 13-year-old ambulance, repairs to the breathing air system, gear for the firefighters, uniforms, fuel, insurance and training and payroll for our personnel.

Many residents believe that our fire department is still a "volunteer" department; this is no longer the case. While we do not employ any full time firefighters or EMS, we have over 30 highly trained part-time members of our department. Most of our members work another job and many of them rotate between multiple fire departments in the area. We strive to have four staff members at the station

24/7. Our response times are quick — approximately 90 seconds to respond to the emergency and, on average, 7 minutes to your door.

The Fire Department is committed to providing all residents of Bethel Township with a high level of service: having personnel "on station" 24 hours a day/seven days a week, maintaining equipment so that it exceeds its expected lifespan, attending public service events, being present at all home athletic events at Bethel Schools, and serving our community with skill and compassion. The men and women who work in our department are highly dedicated and, like most things, the cost for personnel and equipment has risen over the years.
