Election on May 2—Voting Locations in Bethel Township

Tuesday, May 2nd, voters in Bethel Township will head to the polls. There are three issues on the ballot: 2.0 mill Renewal Capitol Improvement Levy and a 7.0 mill General Operations Levy—both for Bethel Local School District and a 1.43 mill Bond issue for Miami Valley CTC. Bethel Township has no issues on the ballot. The polls are open 6:30 am to 7:30 pm on May 2. Early voting begins on Tuesday, April 4 at the Miami County Courthouse in Troy.

- **Bethel West and South Central** vote at the new West Charleston Church of the Brethren 4817 SR 202.
- **Bethel South East and East** vote at the First Baptist Church 8870 SR 571.
- **Huber Heights A and Huber Heights B** vote at the Fire Station in Brandt. These precincts do **not** vote on township issues, but do vote on Bethel School issues.

Chimney Safety Tips

The end of 2016 and the beginning of 2017 statistics show a rise in chimney fires. As it warms, use this time to think about safety for the upcoming season.

- Have your chimney cleaned and inspected.
- Make sure there is a cap to keep debris and animals out of the chimney.
- Keep the tops of chimneys clear of limbs or debris.
- Check to make sure the damper is functioning properly.
- Make sure your Carbon Monoxide detector is working properly.

Bethel Local Schools Renewal Levies

Bethel Local Schools is asking voters to support the NO NEW TAXES Renewals on the ballot May 2. These renewals, a 2 mill Capital Improvement Levy and a 7 mill General Operations Levy *will not cost the tax payers any additional money* over the next five years. The Capitol Improvement Levy is a five year, 2 mil Levy that currently generates approximately \$206,000 per year. This levy has been in place and successfully renewed since 1996. The funds from this levy can only be used for building improvements and repairs. The General Operations Levy is a five year, 7 mil levy that raises just over one million dollars and is used for student supplies, equipment, salaries, fuel, utilities and many other day to day expenses. The General Operations Levy was first passed by voters in 2012. Presently, Bethel Local Schools only receives 4 million dollars from the state to assist with the 11 million dollar budget needed to keep the district running efficiently; the renewal monies help to offset these operating costs. Sensitive to its community and taxpayers, the Board emphasizes that there be no new taxes collected in the renewal.

The money collected from these renewals touches every area of the district from books to facilities. It provides students with positive learning environments and the materials needed to grow and succeed on a daily basis. Looking forward, Bethel's Superintendent, Virginia Potter, stated "The money generated from this renewal will be used to create new learning opportunities for students, provide a more updated and innovative technology infrastructure, purchase new curriculum and textbooks, remodel and expand classrooms and bathroom facilities and supply students with the necessary equipment and educational supplies needed to prepare them to operate in a global community."

Bethel community members have until Monday, April 3 to register to vote for these renewals. Election Day is Tuesday, May 2, and early voting begins on Tuesday, April 4. Trustees Support School's Levy Renewals

On March 14, Bethel Township Trustees unanimously passed a resolution in support of Bethel Local Schools' 2 mill Capital Improvement Levy and 7 mill General Operations Levy that are on the ballot on May 2nd. Both levies are renewals. Trustee Beth van Haaren stated, "Great communities and great schools go hand in hand. We are proud to pass this resolution and to continue the tradition of supporting our school and by extension our township."

Ditch Law in Ohio

Spring is upon us and with it comes lots of rain and the potential for flooding. Per the Ohio Revised Code, the responsibility for the maintenance and improvement of drains, ditches and watercourses, whether established county ditches or not, rests entirely upon the land owners affected and benefitted. It is not the obligation of the County or Township to maintain or improve the storm drainage facilities across any individual's property for either agricultural purposes or the

development of home sites. Please check the open ditches on your property on a regular basis and keep them free of debris. This will help the storm water to move in the ditch and away from your property, which in turn may reduce your risk of flooding. Keeping the ditches clean also minimizes clogging of tiles under your driveway and under the roads, catch basins and other storm water tiles. Remember storm drains are for water movement only, they are not designed to remove grass, gravel, leaves or any other type of waste materials. Cemetery Cleanup

Bethel Township is responsible for maintaining all five public cemeteries in the Township. Bethel West and West Charleston are the only active cemeteries in the Township. Spring clean up in all Township Cemeteries will start on April 17th. Decorations must be removed by April 16th and may be replaced in the cemeteries after May 15th. Any live flowers, artificial flowers or decorations may be removed by the cemetery crews when deemed unsightly, at anytime during the year or if they cause a problem with mowing and maintenance of the Cemetery.
