Bethel Township Fire Department Medical Facility Information

Bethel Township Fire Department responds to over 500 emergency medical service (EMS) calls per year. Frequently, the patient must be transported to a medical facility. Bethel Township crews will offer a wide range of choices on where to go. We transport to:

Upper Valley Huber Heights Emergency Grandview Springfield Reg. Med. Center Wright Patt Air Force Base
Children's Medical Center Soin Medical Center
Miami Valley

Other hospitals such as Kettering Medical Center or Southview Hospital are too far away for our crews to make a quick turn around and get back to protect the Township. For example, a trip to Kettering would take over an hour and half for our crews to return for the next emergency, whereas a trip to Grandview would be under an hour. In addition to the distance, we have to pass other hospitals (including ones in the same network) to reach those destinations. In an effort to provide maximum coverage to the entire Township, it is important for the crews to deliver the patient to the most appropriate hospital in a timely manner. There are also times when the emergency dictates where we take patients. Examples of this include trauma, stroke, burns, and other critical emergencies. We are dictated by our "protocols" to take patients to specified hospitals that are specifically equipped to handle these emergencies. It is also possible that at times emergency rooms close due to high volume; this is called rerouting. We are notified by our dispatch when an ER is closed and we are not able to take patients there.

If you have the medic come to your house and the crews tell you that you or a loved one cannot be transported to your hospital of choice, please realize that they are following policy that has been created to ensure the best possible care for the patient and also provide the highest level of service for the residents of the Township. Burn Regulations

After the insert article in the previous newsletter there were some questions on open burning and recreational fires in the Township. Fires are divided into two classifications: disposal of organic waste (brush, limbs, etc.) and recreational. The following are the directives given to our fire crews regarding open burning and recreational fires.

Disposal of Organic Waste Fires:

- Fires shall be no more than 5 feet x 5 feet x 5 feet high for residential and 10 feet x 10 feet x 10 feet high for agricultural. The agricultural designation is not the zoning classification but the use. Example: a residence on five acres zoned agricultural does not automatically get the larger fire.
- Residential disposal of waste must take place in an area cleared of leaves, high grasses, or other combustible material.
- Agricultural disposal of waste must take place in a tilled field away from large stands of trees, grass fields, or other combustible material.
- Disposal of Waste fires must follow state guidelines. Please visit www.rapca.org for more information.

Recreational Fires:

- Recreational fires shall be no more than 3 feet x 3 feet x 2 feet high.
- Recreational fires shall be no longer than 4hrs in duration and no more than 3 per week.

All Fires (Recreational and Disposal):

- Shall be a minimum of 25 feet from any structure and a minimum of 50 feet from any property line.
- Shall be attended at all times.
- Shall meet the requirements of any state or local "burn bans."
- Absolutely none of the materials listed below shall be burnt at any time:
 - Garbage/Trash
 - Materials containing rubber, grease and asphalt or made from petroleum, such as tires, cars and auto parts, plastics or plastic coated wire; and
 - Dead animals—unless approved for control of disease by a governing agency

Fires not meeting the above criteria shall be extinguished by the Fire Department.

Please note that the fire department does not govern the smoke generated by any of these fires. If there is an issue with the smoke generated from a fire, please contact the Regional Air Pollution Control Agency at (937) 225-4435 or visit the website at www.rapca.org.

Road Repair

The Township is pleased to announce that we will be repaving three Township roads this summer. The quotes for Scarff Road (SR 571 to US Rt. 40), East and West Haskett and Wonder Way came in lower than expected. The actual costs are Scarff (from 40 to 571): \$171,301.60; Wonder Way: \$19,106.00; East Haskett: \$32,739.20; West Haskett: \$34,238.40 for a total of \$257,385.20. In addition, we have \$20,000 to \$40,000 of base and culvert repair to do to the curve connecting East and West Haskett. The repaving projects will begin sometime in mid- to late-July, depending on the weather. The Township did not do any repaving projects in 2016 or 2017. The monies saved from those years, in addition to funds from the 3.8 mill Levy will be used for the projects. In addition to paving projects, the Township will be doing crack sealing on road surfaces as well as repairing potholes. Please give us a call if you see a pothole we have not fixed or have any questions about our roads.
