# Land Use Plan Update

On Monday, August 2<sup>nd</sup> and Tuesday, August 3<sup>rd</sup> residents gathered to offer input on the existing Land Use Plan. JT Development Consulting, LLC was hired by the township to do a strategic review of the current Land Use Plan and to develop recommended updates and modifications to the Plan. The current Land Use Plan was adopted in 2009, and in keeping with generally accepted planning practices, was due for a periodic review and update. The consultants used a SWOT process (Strengths, Weaknesses, Opportunities and Threats) to gather citizen input.

The results are in. Based on input from approximately 60 residents over both evenings, it is recommended that these top 5 areas should be a primary focus the next phase of the Strategic Land Use Plan update:

- 1. Land Use Plan Implementation and Accountability
- 2. Communication Community Consensus
- 3. Infrastructure Roads, Traffic, Utilities, Township Services
- 4. Quality of Life Rural Character of the Township
- 5. Targeted Development Clustering Compatible Uses

The next public input meetings will be held on Tuesday, October 5 and Wednesday, October 6 at the Fire Station in Brandt from 6:30 pm—8:30 pm. # **Election Information—Tuesday, November 2**

Tuesday, November 2nd, voters in Bethel Township will head to the polls. There are 4 candidates for school board for three full term seats, 5 candidates for Township Trustee for two full term seats and 1 candidate for Township Trustee for one half term seat. The Township has two issues on the ballot: 1.0 mill Replacement Police Levy and 4.9 mill Renewal Fire Levy. Bethel Local Schools has two ballot issues and both are renewals.

Early voting begins at the courthouse in Troy on Tuesday, October 5 and continues until Monday, November 1. For specific information on dates and times for early voting, please visit the Board of Elections website: https://www.boe.ohio.gov/miami/

- Bethel Huber Heights A and B also vote at the new West Charleston Church of the Brethren 4817 SR 202. These precincts *DO NOT* vote on township issues, but do vote on Bethel School issues and Miami County issues.

In today's tight economy, supporting and retaining a highly skilled workforce is critical to maintaining high quality services. At the township, we recognize that our Fire Department is a service that our residents rely on in times of need, and we have invested both time and resources in training and equipping our crews.

In addition to hands on training and equipment, we are focusing efforts on improving both the physical and mental health of our crews. To improve physical wellness, the Fire Department is working with Kettering Health Network to design a fitness program to increase wellness and reduce the potential for injury.

To improve mental wellness the Fire Department, working with Trustee Carolyn Wright, has rolled out a Mental Health Initiative, focused on addressing the impact of trauma on first responders. The statistics from the Firefighter Behavioral Health Alliance are stark and sobering:

 First Responders are five times more likely to be affected by PTSD than civilians.

• There are 30% more first responder fatalities from suicide than line of duty deaths.

The Bethel Township Mental Health Initiative is focused on exploring best practice programs across the state to develop a program that includes crisis debriefing, peer support and access to evidenced based trauma treatment for crew members who have been impacted by difficult calls. Chief Andy Ehrhart has shown real leadership in this work and continues to advocate tirelessly for the men and women who re-

spond when we call. We are proud to support our First Responders, and grateful for their service.

## The 4.9 mill Fire/EMS Levy is on the ballot in November as a RENEWAL

The 4.9 mill Fire/EMS Levy is on the November ballot as a renewal. No new taxes. In November of 2016 Bethel Township Voters approved an increase to the previous 2.0 mill levy. This increase allowed the Fire Chief to change the staffing model from a volunteer program with small stipends to a part-time model with crews paid hourly to be in the station 24 hours a day. This allowed us to better our response times, ensure on-duty personnel and ultimately provide better service to you, the residents.

This levy pays all the wages for our fire department personnel. We have 29 part-time dual certified Firefighter/EMS first responders. In 2020, this levy generated \$678,664.06 and payroll costs were \$577,972.26. The remainder is set aside for capitol purchases such as firetrucks, ambulances, and equipment. Equipment costs can be very expensive. For example, in 2019 the Fire Department purchased a new medic unit at a cost \$220,000.00. Currently Paramedic Firefighters earn \$15/hr and Basic EMT/Firefighters earn \$13/hr.
