Township Administrator and Fire Chief Retires

On December 12 at the Trustee Meeting, Township Administrator and Fire Chief Andy Ehrhart announced his retirement, effective December 31, 2023. Andy's unwavering dedication to Bethel Township has been exceptional. Throughout any given day, he could be found engaging with a resident on drainage concerns, overseeing multiple fire crews, collaborating with the county engineer on road paving, coordinating with the Fiscal Officer on capital improvement financing, updating the township website, assessing safety and evacuation routes at the school, crafting meeting agendas for the trustees, and handling numerous other tasks, both significant and minor.

With our small and well-cross-trained township and fire staff, Andy Ehrhart served as the linch-pin that kept us cohesive and enabled us to function efficiently. There was no task too small or large for him—from personally re-tiling bathroom floors on a weekend to save costs for the township, securing grants for crucial Fire Department equipment, to fixing a U Joint on the mini dump.

As Andy embarks on his well-deserved retirement, we extend our heartfelt wishes for all the best in his future endeavors. We express profound gratitude for his exemplary leadership over the past 14 years, which has left an indelible mark on Bethel Township.

Appreciation for Fiscal Officer and Trustee

Bethel Township would like to thank Fiscal Officer Deborah Watson for her 19 1/2 years of service and Township Trustee Don Black for his 3 1/2 years of service. Both officials lost their re-election bids in November. Their last day in their township roles will be Dec. 31, 2023.

Deborah Watson managed all financial aspects of the township and the fire department. She used her knowledge to invest township funds wisely, to apply for grants to stretch township dollars further, to budget township funds effectively and to ensure that funds were spent for the appropriate use. Her ability to save township funds for future use without compromising current services was phenomenal. She continually looked for ways to stretch a dollar further and made sure we had matching funds for over \$5 million in grant awards. Debbie was regarded as a compassionate mentor to many of the employees – always lending a helping hand or a listening ear. As

a leader, she went above and beyond to provide exceptional accounting and forecasting services to the township.

Don Black worked hard to secure the future of the township by fighting annexation and promoting reasonable development. Don's perseverance is largely responsible for permanently preventing development of 162 acres of land vulnerable to annexation in 2021. He donated his time and resources to save the township taxpayers almost \$100,000 by demolishing buildings at the Siler Property, by fixing drainage issues and by actively working to clean up abandoned and foreclosed properties. He also helped out Bethel Local Schools, constructing a connector road between the High School and the new Elementary School.

We would like to express our sincere gratitude and appreciation to both Don and Debbie for their dedication to Bethel Township and wish them much success going forward.

Chief Schiebrel was appointed by resolution on the Dec. 26, 2023 meeting in a 3-0 vote.

In November, our Fire Department held their final training of the year. This "capstone" training ties together all the bigger trainings done throughout the year. This training began on a Friday and was complete on a Sunday. The Search and Rescue Trailer from the State Fire Academy was utilized along with custom made props like a breach wall simulator, forcible entry door and entanglement traps.

Our crews trained on VEIS, (vent, enter, isolate, search), Mayday situations and radio communication, handline advancement, search and rescue, ladder deployment, breached wall escape, down firefighter removal, forcible entry, and confined space. These trainings reinforce the skills our fire/EMS personnel need to respond safely and quickly and to provide the best service possible to our community.

Zoning Code Reminder—Mobile Homes and Recreational Vehicles

We get a number of calls asking what the rules are for living in RV's in the township. Below is the zoning code covering most of these questions. The complete regulations can be found in our Zoning Code—Section 30.16 Auxiliary Uses

Section 30.16 Mobile Homes and Recreation Vehicles This Section shall apply to all existing mobile homes that were located prior to the adoption of this Zoning Resolution.

- A. No person shall occupy a recreational vehicle as a residence in any district as a temporary or permanent residence.
- B. No person shall occupy a mobile home as a residence outside an approved and licensed mobile home park or trailer court except as provided in the A-2 General Agricultural District.
- C. No mobile or manufactured home may be stored or parked in any district other than: 1. An approved and licensed mobile home park or trailer court, or 2. B-1 General Business, I-1 Light Industrial and I-2 Heavy Industrial.
- D. No recreational vehicle or boat may be stored in any required front yard or in front of the front building line of the building, whichever is farthest from the right of way, of any residential district.
- E. No recreational vehicle or boat may be parked in any required front yard or in front of the front building line of the building, whichever is farthest from the right of way, of any residential district for a period of more than 72 consecutive hours.
- F. No recreational vehicle or boat shall have a permanent connection to electric, water, gas or sewer facilities in any residential district.
