Case V-03-14: A request from Randy Britton of 209 Ranchview Drive Vandalia Ohio 45377. The applicant requests a variance to decrease the side yard setback needed to build a house from the required twenty (20) feet to five (5) feet and to decrease the front yard setback from fifty (50) feet to (ten) 10 feet. The property is located at 6825 US RT 40 Tipp City Ohio 45371.
