New Business

Case CU-02-17: A request from JC Snediker, 6165 St. Rt. 201, Tipp City, OH 45371, for a conditional use on his parcel that will allow him to use the parcel and existing barn for a wedding and events venue. The parcel is zoned A-2. The property is identified as Miami County Parcel ID #A01-059130.

Mr. Caskey presented the staff report.

Mr. Caskey asked if there were any questions for him.

None.

Ms. Fisher asked if the applicant was available. Mr. Snediker was sworn.

Mr. Snediker presented his plan for the barn and how it would be used for weddings and other events.

Ms. Fisher asked if there were questions for Mr. Snediker from the board.

Mr. Owens asked if this was going to be like A Secret Garden on US 40.

Mr. Snediker said it would be similar.

Ms. Fisher asked if there were any comments from the audience.

Mr. Ryan Lostedder stated that he is the adjoining property and he is totally against the CU. He read a letter from another neighbor with several questions to be answered (letter attached).

1. What events would be allowed?

Mr. Snediker said weddings, office parties, graduation parties, etc.

2. Will there be permanent structures added to the property?

Mr. Snediker said no, only the barn will be used. There will be a porta john trailer.

3. Floor loads, food, etc.?

Mr. Snediker said Miami County will be contacted for any of these issues.

4. Alcohol?

Parties would supply their own.

5. Hours?

Mr. Snediker: Saturdays to start and maybe other days added. The parties would conform with the Bethel Township noise resolution guidelines.

Mr. Lostedder said he moved to Bethel Township for the quiet and peaceful use of his property and wouldn't have done so if he had known there would be an event venue next door. Since it's not zoned for that, it should not be approved.

He asked about car engines running, honking horns, drunk drivers leaving headlights on his house, and the decline in property values.

Mr. Owens asked about how close cars would be to the neighbor's home.

Mr. Snediker stated that it would be 70 feet at least.

Ms. Rachel Taylor spoke against the CU for the same reasons.

Mr. James Walsh spoke against the CU for the same reasons. He also stated he specifically did not open his machine shop on his property because he wouldn't want to annoy the neighbors.

Karen Niswonger spoke against the CU and agreed with previous speakers.

Ms. Lorna Furderer spoke about the concerns neighbors had with 3 Springs Pay Lake and how they didn't come to pass. She said Mr. Snediker should be given a chance. She also noted Mr. Gale Halderman in Brandt had Mustang car shows and they were never a problem with neighbors.

Mr. Lostedder noted that it's not a "chance," since if approved, they will be stuck with it.

Mr. Snediker responded to all speakers by stating he would certainly control anything he can on the property.

Ms. Fisher asked if there were any more comments.
