The applicant requests a triple variance to increase the total maximum size of accessory structure from twenty-four Hundred (2400) sq ft to Forty-eight Hundred (4800) sq ft, increase the amount of accessory structures on the parcel from two (2) to three (3), and to increase the permitted height from fifteen (15) ft to twenty-four (24) ft located at 2534 US 40.
