A RESOLUTION SETTING EMPLOYEE AND ELECTED OFFICIAL CONTRIBUTIONS TO HEALTH CARE COVERAGE AND ESTABLISHING COVERAGE FOR THOSE EMPLOYEES AND ELECTED OFFICIALS WHO ARE COVERED UNDER MEDICARE

WHEREAS, THE BETHEL TOWNSHIP BOARD OF TRUSTEES ENTERED INTO A CONTRACT WITH UNITED HEALTH CARE, INC. TO RENEW HEALTH AND LIFE INSURANCE FOR TOWNSHIP OFFICIALS AND FULL TIME EMPLOYEES VIA RESOLUTION #16-05-047, AND

WHEREAS, THE BOARD OF TRUSTEES OF BETHEL TOWNSHIP, MIAMI COUNTY FEEL IT IS FISCALLY RESPONSIBLE FOR EMPLOYEES AND ELECTED OFFICIALS TO CONTRIBUTE TO THE COSTS OF HEALTH CARE COVERAGE UNDER RESOLUTION #16-05-047, AND

WHEREAS, THE BOARD OF TRUSTEES HAVE REALIZED THAT SOME EMPLOYEES ARE COVERED UNDER MEDICARE AND HAVE HISTORICALLY BEEN OFFERED REGULAR COVERAGE FROM UNITED HEALTH CARE AT A HIGH PREMIUM, AND

WHEREAS, THE BETHEL TOWNSHIP ADMINISTRATOR AND FISCAL OFFICER HAVE BEEN WORKING WITH MCGOHAN BRABENDER TO MAKE SURE THAT OUR EMPLOYEES AND ELECTED OFFICIALS ARE OFFERED QUALITY COVERAGE FOR AN AFFORDABLE PRICE, AND

WHEREAS, MCGOHAN BRABENDER HAS DISCOVERED THAT THE BEST OPTION FOR EMPLOYEES AND ELECTED OFFICIALS WHO ARE COVERED UNDER MEDICARE IS TO OFFER A MEDIGAP PLAN THRU AETNA INSURANCE THAT IT INTEGRATED WITH OUR GROUP HEALTH PLAN AND PAID DIRECTLY BY THE TOWNSHIP AS PART OF SAID GROUP PLAN, AND

WHEREAS, THE BOARD OF TRUSTEES BELIEVE THAT COVERAGE FOR EMPLOYEES AND ELECTED OFFICIALS COVERED UNDER MEDICARE SHOULD BE FAIR AND EQUITABLE TO THOSE COVERED UNDER UNITED HEALTH CARE, AND

WHEREAS, TO MAKE THE COVERAGE FAIR AND EQUITABLE THE TOWNSHIP WILL PROVIDE A SELF-ADMINISTERED HRA ACCOUNT IN THE SAME AMOUNT LISTED IN RESOLUTION #16-05-047 AS THOSE WITH HSA COVERAGES, THEREFORE

BE IT RESOLVED, THAT THE BOARD OF TRUSTEES OF BETHEL TOWNSHIP, MIAMI COUNTY THAT:

SECTION 1. UNITED HEALTH CARE, INC. WILL CONTINUE TO BE THE PROVIDER OF HEALTH AND LIFE INSURANCE SERVICES TO THE ELECTED OFFICIALS AND FULL TIME EMPLOYEES OF THE BOARD OF TRUSTEES OF BETHEL TOWNSHIP, MIAMI COUNTY AS STATED IN RESOLUTION #16-05-047.

SECTION 2. EMPLOYEES AND ELECTED OFFICIALS SHALL CONTRIBUTE TO THE COST OF HEALTH CARE AS THE FOLLOWING RATES:

- 1. <u>EMPLOYEES:</u> SINGLE COVERAGE: \$25/PAY PERIOD. COVERAGE WITH MORE THAN JUST THE EMPLOYEE \$50/PAY PERIOD.
- 2. <u>TRUSTEES:</u> SINGLE COVERAGE: \$50/MONTH. COVERAGE WITH MORE THAN JUST THE EMPLOYEE \$100/MONTH.
- 3. <u>FISCAL OFFICER:</u> SINGLE COVERAGE: \$10/MONTH. COVERAGE WITH MORE THAN JUST THE EMPLOYEE \$20/MONTH.

SECTION 3. THOSE COVERED UNDER MEDICARE WITH CONTRIBUTE THE SAME AMOUNT LISTED ABOVE FOR THE MEDIGAP POLICY INTEGRATED WITH THE GROUP PLAN. THOSE WHO HAVE PRESCRIPTION PLAN AND PART B COVERAGE MAY SUBMIT THE PREMIUMS TO THEIR HRA ACCOUNTS FOR RE-IMBURSEMENT.

SECTION 4. HSA ACCOUNTS AND HRA ACCOUNTS BE FUNDED AS LISTED IN RESOLUTION #15-05-047.

RESOLUTION #16-05-050

A RESOLUTION AUTHORIZING THE PURCHASE TO THE PROPERTIES IDENTIFIED AS PARCEL ID# A01-86081 AND ID# A01-86082 BOTH LOCATED ON US ROUTE 40 AT A PURCHASE PRICE OF \$12,500 EACH.

WHEREAS, THE BETHEL TOWNSHIP BOARD OF TRUSTEES HAVE BEEN OFFERED AN OPPROTUNITY TO PURCHASE THE PROPERTIES IDENTIFIED AS PARCEL ID# A01-86081 AND ID# A01-86082 LOCATED ALONG US ROUTE 40, AND

WHEREAS, THE BOARD OF TRUSTEES OF BETHEL TOWNSHIP, MIAMI COUNTY HAVE BEEN OFFERED THE PROPERTIES FOR THE COMBINED PURCHASE PRICE OF \$25,000 (\$12,500 PER PROPERTY), AND

WHEREAS, THE PROPERTIES ARE ADJACENT TO LAND OWNED BY THE TOWNSHIP, AND

WHEREAS, BETHEL TOWNSHIP WILL BE ABLE TO UTILIZE THESE PROPERTIES FOR POTENTIAL FUTURE USE AS WELL AS ELIMINATE BLIGHTING CONDITIONS THAT CURRENTLY EXIST, THEREFORE
