# ADMINISTRATOR REPORT

1: There are 5 resolutions on your agenda tonight:

- A Resolution for the Zoning Case held earlier this evening
- A Resolution to accept the resignation of Nick Magoteaux from the Fire Department. Lt. Magoteaux has accepted a new full time job and does not have availability for Bethel
- A Resolution to authorize the payment for repair of Fire Engine 6. It had a water leak in the front intake and was draining water from the tank. A new part had to be fabricated and a new valve installed to repair the leak.
- A Resolution for payment of the annual user fee for Emergency Reporting. This is the cloud based system we enter all of our fire and EMS runs into. It also tracks our fire inspection, maintenance, training and many other fire/EMS related items.
- A Resolution to authorize the purchase an AED from Stryker Corp. We have been in the process of making sure all of our fire equipment is outfitted with an AED. After this purchase we are one away from completing this. These funds will be reimbursed by the State EMS Grant

2: The Open House was held on Sunday. Despite some rainy weather, it was well attended. Good comments were received from the citizens.

**3**: The water tower is currently under repair. It was discovered to have an approximately 1 inch in diameter leak in the tank itself. There will be some pressure issues during the repair.

4: The Fire Department will be participating in a live active shooter drill tomorrow at Tipp City Schools. They are running it as a full scale incident, so just for info it is a scheduled drill.

5: The Fire Department will be visiting the school on this week on October 10<sup>th</sup> and 11<sup>th</sup> for Fire Prevention Week. There will be 375 kids over the two days.
