

A RESOLUTION AUTHORIZING THE PURCHASE AND INSTALLATION OF VINYL FLOORING THE FIRE STATION/TOWNSHIP OFFICES UTILIZING CARES ACT FUNDING FROM BUD POLLYS FLOORING CENTER, TIPP CITY, OH AT A COST NOT TO EXCEED \$29,000

WHEREAS, DUE TO THE COVID 19 PANDEMIC, BETHEL TOWNSHIP RECEIVED FUNDS FROM THE CARES ACT TO COVER COVID RELATED EXPENDITURES, AND

WHEREAS, OF THE AUTHORIZED ITEMS TO BE UTILIZED FOR EXPENDITURE ARE ITEMS USED TO PROMOTE SANITARY CONDITIONS IN THE WORKPLACE, AND

WHEREAS, THE TOWNSHIP FIRE STATION/GOVERNMENT OFFICES HAVE CARPETED AREAS THAT ARE NOT CONDUCIVE TO UTILIZATION OF UV-C LIGHTING TO ELIMINATE VIRUS AND BACTERIA CONTAMINATION. STUDIES HAVE SHOWN THAT SWEEPING AND UTILIZATION OF UV-C LIGHTING ON CARPET ONLY ELIMINATE 87% OF THESE CONTAMINATES; HOWEVER, SOLID SURFACE RESULTS ARE CLOSER TO 99.9% EFFECTIVE, AND

THEREFORE, IN AN EFFORT TO ELIMINATE POSSIBLE CONTAMINATION IN THE WORKPLACE, BE IT RESOLVED BY THE BOARD OF TRUSTEES OF BETHEL TOWNSHIP, MIAMI COUNTY, TO PURCHASE AND HAVE INSTALLED HARD SURFACE VINYL FLOORING FOR THE FIRE STATION AND TOWNSHIP OFFICES AT A COST NOT TO EXCEED \$29,000 FROM BUD POLLYS FLOOR CENTER, TIPP CITY, OHIO.

A RESOLUTION AUTHORIZING THE PURCHASE OF PERMANENT MOUNT UV-C LIGHTING IN THE BETHEL TOWNSHIP MEDIC UNITS FROM BIO TECH UV AT A COST NOT TO EXCEED \$5,496 WHEREAS, DUE TO THE COVID 19 PANDEMIC, BETHEL TOWNSHIP RECEIVED FUNDS FROM THE CARES ACT TO COVER COVID RELATED EXPENDITURES, AND

WHEREAS, OF THE AUTHORIZED ITEMS TO BE UTILIZED FOR EXPENDITURE ARE ITEMS USED TO PROMOTE SANITARY CONDITIONS IN THE WORKPLACE, AND

WHEREAS, THE TOWNSHIP MEDIC UNITS ARE EXPOSED TO COVID PATIENTS AND OTHER HARMFUL VIRUSES, PROVIDING THE UTILIZATION OF UV-C LIGHTING TO ELIMINATE VIRUS AND BACTERIA CONTAMINATION ARE PARAMOUNT DURING THIS PANDEMIC. STUDIES HAVE SHOWN THAT UTILIZATION OF UV-C LIGHTING CAN ELIMINATE UP TO 99.9% OF THE CONTAMINATION,

THEREFORE, IN AN EFFORT TO ELIMINATE POSSIBLE CONTAMINATION IN THE WORKPLACE, BE IT RESOLVED BY THE BOARD OF TRUSTEES OF BETHEL TOWNSHIP, MIAMI COUNTY, TO PURCHASE UV-C LIGHTING FOR BOTH BETHEL TOWNSHIP MEDIC UNITS FROM BIO TECH UV AT A COST OF \$5.496.
