



## **ADMINISTRATORS REPORT**

There are six resolutions on your agenda tonight.

The first Resolution is for the final step in placing the fire levy on the ballot. It is the resolution that goes to the Board of Elections.

The next item has been struck from the agenda. This is due to having to redo the intent resolution to the auditor for the police levy. The reason for this is: during the review process by the Miami County Auditor and Prosecutor's office it was missed that the year the levy was first to be placed on the tax duplicate. It was not clear due to the fact that this is a continuing levy. After further legal review we have been advised to repeal the original resolution and pass one with a correction. This will require a new certification from the Auditors office which will be issued tomorrow. Lastly this will require a Special Meeting of the Trustees on Thursday July 29, 2021 at 5:30pm in order to pass the final resolution and get it to the Miami County Board of elections.

The next two resolutions are for resignations from the Fire Department. Alex Segretto is leaving us for a full time job in Fairborn and Mark Wysong has taken a position with Brookville Fire Department.

The next Resolution is to appoint Austin Hoffman to the Fire Department

The last two Resolutions are the ones I talked about earlier with the repeal and new Resolution.

## A RESOLUTION DECLARING IT NECESSARY TO LEVY A TAX IN EXCESS OF THE TEN MILL LIMITATION

The Board of Trustees of Bethel Township, Miami County, Ohio, met in regular session on the 27<sup>th</sup> day of July, 2021 at the Township Hall located at 8735 South Second Street in Brandt, Tipp City, Ohio 45371,

TRUSTEE CAROLYN WRIGHT TRUSTEE DON BLACK TRUSTEE BETH VAN HAAREN

Trustee **BLACK** moved and Trustee. **VANHAAREN** seconded for the adoption of the following Resolution:

**WHEREAS**, the Board of Trustees of Bethel Township is the taxing authority of Bethel Township Fire District One, which fire district consists of all of the unincorporated territory contained within Bethel Township, Miami County, Ohio, lying outside of the city of Huber Heights, Miami County, Ohio, and the City of Tipp City, Miami County, Ohio; and

WHEREAS, it appears that the amount of taxes which may be raised within the ten mill limitation will be insufficient to provide an adequate amount for the necessary requirements of Bethel Township Fire District One, Miami County, Ohio, and the Board of Trustees of said Township, did, pursuant to Ohio Revised Code section 5705.03(B), request and secure from the Auditor of Miami County, Ohio, the certification of said official as to the total tax valuation of the property within Bethel Fire District One which is \$159,962,550.00, and of the estimated tax revenue that will be produced annually by four and nine-tenths (4.9) mills, assuming the tax valuation of the property within the area of Bethel Township Fire District One remains constant throughout the life of the levy, which is calculated to be \$719,262.38.

**NOW, THEREFORE, BE IT RESOLVED**, by the Board of Trustees of Bethel Township, Miami County, Ohio, no fewer than two-thirds (2/3) of all of the members thereof concurring, that it is necessary to levy a tax in excess of the ten mill limitation for the benefit of Bethel Township Fire District One for the purpose of funding:

# THE PROVISION OF FIRE AND EMERGENCY MEDICAL SERVICES IN BETHEL FIRE DISTRICT ONE, MIAMI COUNTY, OHIO

as permitted by Section 5705.19(I) of the Ohio Revised Code, in a total rate and amount which shall not exceed four and nine-tenths (4.9) mills for each one dollar (\$1.00) of valuation which amounts to forty nine cents (\$0.49) for each one hundred dollars (\$100.00) of valuation, to be levied for a period of five (5) years and to be placed upon the tax lists and duplicate beginning in tax year 2022, as is permitted by Section 5705.191 of the Ohio Revised Code, and to remain on the tax lists and duplicate for tax years 2023, 2024, 2025 and 2026, and to be first due and collected in the calendar year 2023 and to be further due and collected in the calendar years 2024, 2025, 2026 and 2027; which proposed levy shall be a **RENEWAL LEVY**, which shall renew an existing levy in the same amount and for the same purpose, and which will effect the imposition of taxation for said purpose; and be it further

**RESOLVED**, that the question of levying additional taxes be submitted to the electors within Bethel Township Fire District One, Miami County, Ohio, at the general election to be held at the usual voting places within the said area on the  $2^{nd}$  day of November 2021; and be it further

**RESOLVED**, that the tax levy be placed upon the tax lists and duplicate and to remain on the tax lists and duplicate as is set forth hereinabove, if a majority of the electors voting thereon vote in favor of said proposal; and be it further

**RESOLVED**, that the Fiscal Officer of Bethel Township Miami County, Ohio, be, and said officer hereby is authorized and directed to certify a true and correct copy of this Resolution, and to direct the same to the Board of Elections of Miami County, Ohio, and, further, that said officer request that the said Board of Elections cause notice of election on the question of levying said tax to be given as required by law.

Resident Natalie Donahue heard rumors that Huber Heights bought land in Bethel. Have the Trustees heard anything? She heard that it was between Wildcat-Ross and Sullivan.

Trustee's and Administrator Ehrhart stated they have not heard anything.

Mrs. Donahue asked if anyone looked at Huber Heights meetings on line?

Trustee Vanhaaren checks their meetings monthly, most legal conversations done in Emergency Meetings.

Mrs. Donahue asked "What do we do next? Seems like we are just letting this happen. Seems like we have no plan".

Trustees said we can do nothing once property is sold and goes to Huber Heights with annexation. Trustee Vanhaaren reviewed prior annexation of Township land. She also stated how rules are stacked in municipalities favor. We are continuing to look for ways to fight annexation, such as legislation through the Ohio Township Association, Facilities Planning Area and agricultural preservation. Resident Julie Reese asked "What if a large group of land owners go together to buy land such as a consortium?

Trustee Vanhaaren stated that is only good if everyone holds up their end of the deal. She then referred to Beavercreek Township and their struggles.
