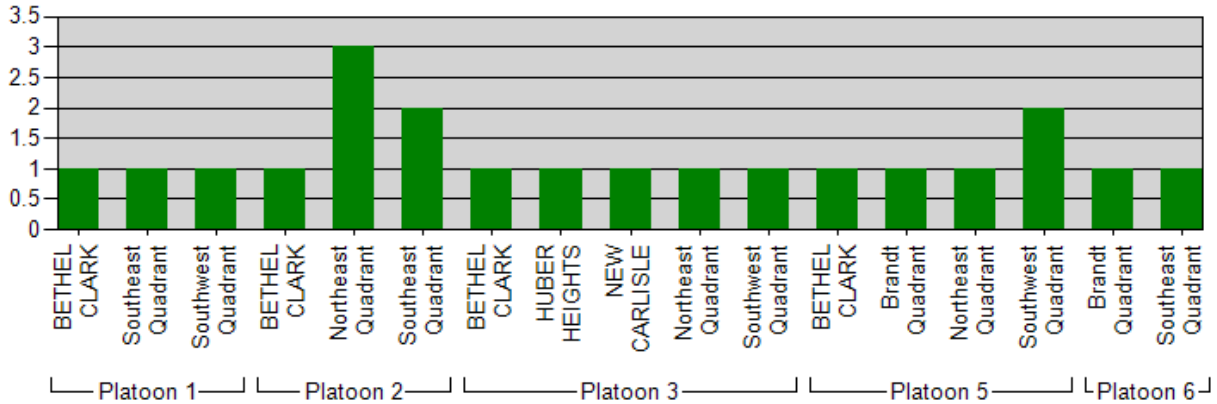

A RESOLUTION TO APPROVE THE MIAMI SOLID WASTE MANAGEMENT DISTRICT'S AMENDED DRAFT SOLID WASTE MANAGEMENT PLAN

WHEREAS, THE PLAN WAS PREPARED IN ACCORDANCE WITH OHIO REVISED CODE (“ORC”) SECTION 3734, THE STATE OF OHIO’S SOLID WASTE MANAGEMENT PLAN AND THE OHIO ENVIRONMENTAL PROTECTION AGENCY’S GUIDELINES. THE PLAN ALSO DESCRIBES STRATEGIES AND PROGRAMS THAT WILL BE IMPLEMENTED TO MEET OR EXCEED THE MINIMUM STATE WASTE REDUCTION GOALS AND OBJECTIVES. THE MIAMI SOLID WASTE MANAGEMENT DISTRICT (“DISTRICT”) COMPLETED THE DRAFT AMENDED SOLID WASTE MANAGEMENT PLAN (“PLAN”) AND SUBMITTED IT TO THE OHIO ENVIRONMENTAL PROTECTION AGENCY FOR REVIEW AND COMMENT ON DECEMBER 29, 2020 AND THE OHIO ENVIRONMENTAL PROTECTION AGENCY PROVIDED COMMENTS IN A NON-BINDING ADVISORY OPINION ON FEBRUARY 12, 2020. THE DISTRICT’S POLICY COMMITTEE HAS REVIEWED THE NON-BINDING ADVISORY OPINION RECEIVED FROM THE OHIO ENVIRONMENTAL PROTECTION AGENCY AND TAKEN THESE COMMENTS INTO CONSIDERATION AND INCORPORATED CHANGES INTO THE AMENDED PLAN AS APPROPRIATE. THE DISTRICT HAS CONDUCTED A 30-DAY COMMENT PERIOD FROM JULY 12, 2021 TO AUGUST 10, 2021 AND A PUBLIC HEARING WAS HELD ON AUGUST 13, 2021 TO PROVIDE THE PUBLIC AN OPPORTUNITY TO COMMENT ON THE PLAN, AND;

WHEREAS, THE PLAN PROVIDES FOR A FEE SCHEDULE THAT GENERATES THE REQUIRED REVENUE TO COVER THE COSTS OF IMPLEMENTING THE STRATEGIES AND PROGRAMS DESIGNED TO MEET OR EXCEED THE MINIMUM STATE WASTE REDUCTION GOALS AND OBJECTIVES, THEREFORE,

BE IT RESOLVED, THAT THE BETHEL TOWNSHIP, LOCATED WITHIN THE JURISDICTION OF THE , MIAMI SOLID WASTE MANAGEMENT DISTRICT, THAT:

SECTION 1. THESE MEMBERS HEREBY ACKNOWLEDGE RECEIPT OF THE AMENDED DRAFT PLAN.

SECTION 2. BETHEL TOWNSHIP APPROVES THE DISTRICT SOLID WASTE MANAGEMENT PLAN;

SECTION 3. THE CLERK IS HEREBY DIRECTED TO SEND THE DISTRICT A COPY OF THIS RESOLUTION TO THE ATTENTION OF MR. BRAD PETRY, SOLID WASTE COORDINATOR,
