1. Discussion of Zoning Director responsibilities

- a. Prepare zoning agendas and attachments, public notices, organizing case files
- b. Notify Boards of meetings and distribute packages for review
- c. Publish official notices which will now be on the Township website and social media
- d. Notify newspapers/reporters and Trustees of Public Hearings held by Trustees
- 2. Discussion of Board responsibilities
  - a. Tell Zoning Director if member wants to be paid for meetings & fill out W-4 or waiver if not
  - b. Good idea for members to get separate email for Township business because entire personal email may be subject to public disclosure in the event of a lawsuit
  - c. Attendance and notifications if member must miss a meeting, please notify the Zoning Director
  - d. Conflicts of interest reasons to recuse due to conflict of interest were discussed
  - e. Voting criteria voting criteria for BZA is dictated by the Ohio Revised Code, voting criteria for ZC is the Township's Zoning Resolution
- 3. Discussion of Trustee responsibilities
  - a. BZA & ZC: appoint, suspend, and remove members
  - b. ZC cases: hold public hearings prior to vote
  - c. ZC cases: consider recommendation of ZC and vote on the cases
  - d. Initiate amendment changes to the Bethel Township Zoning Resolution
- 4. Discussion of Bethel Township Zoning Code updates
  - a. Authorized by Resolution #24-03-033: a resolution directing the planning & zoning department to initiate text amendment changes to the Bethel Township Zoning Resolution

- b. Several items recommended for review for potential update recommendations Trustee Reese provided a list of items that had been brought to her attention by Township residents or others since the last zoning code updates:
  - i. Minimum lot size and road frontage requirements many folks in Township want 5 acre minimum
  - ii. Should we allow truck parking on gravel on business zoned parcels?
  - iii. Should we add a percentage of green space required for R1-AAA?
  - iv. Should we move some automatic "by right" uses to conditional uses?
  - v. Should minimum size of house commensurate with lot size?
  - vi. Require PD plan if over a certain number of acres to prevent developer from changing the plan
  - vii. Require developer to plan for drainage and not just destroy existing tiling
  - viii. Senior housing 55+
  - ix. Junk vehicles see Concord Twp resolution, Sheriff has to have a definition of junk vehicle in order to enforce it. Need to reference the ORC in our zoning code see 505.173 Storage of junk motor vehicles.
  - x. Require water flow/pressure requirements for wells for new construction
  - xi. Wind & solar farms
  - xii. Short term rentals (permitted to the extent the ORC allows)
  - xiii. Only allow one split from a large parcel, then has to go to BZA (Versailles)
  - xiv. Section 2.06 application frequency limits may need exception for new owner since CU expires when ownership changes
- c. Zoning board input on items that need review zoning boards should review the current zoning code and make update recommendations
- 5. Land Use Plan update
  - a. Would like the make up of the land use plan update committee to be a mix of elected officials,
     Township staff, community members, and a couple people from each zoning board let the
     Zoning Director know if interested
