PUBLIC COMMENT FOR ITEMS ON AGENDA

Resident Carol Ratterman of 6495 Bethelville Dr, came forward and stated there was too much gravel on the road. Trustee Vanhaaren said that this was the same mixture that was used on Pisgah Rd 3 years ago and Pisgah did very well with this process. She also stated that the process wasn't helped by the cooler temperatures this past week. Next weeks' hotter temperatures should help process.

Resident Judy Merrick of 6812 Bethelville Dr stated that most residents on her street are very unhappy due to the dust, and that some people are on oxygen. Children can't ride bikes, to walk on street is very tough. She asked if rolling the pavement on a hot day would help.

Trustee Hirt responded that waiting to pave the road would have been a mistake.

Trustee Vanhaaren stated that we will call contractor and see about rolling.

Resident Caroline Thompson of 6825 Bethelville Rd said that there were defects in the road, hills, mounds of gravel.

Administrator Andy Ehrhart said he will call the contractor and have them come back and see if they can sweep some of the gravel away.

Resident Terry Bennett asked Trustees if they could take a look at Ballentine Rd, they used same process but sprayed a clear seal on top.

Trustees said they would check into this also.
