ADMINISTRATORS REPORT

Resolution 12-11-144	This resolution renews the Township’s contract with the Miami County Sheriff’s Department for fiscal year 2013 for additional policing. This contract reflects an increase of 2% from last year’s contact. The 2% increase comes from the negotiated 2% pay increase for deputies. The overall cost of the contract is \$103,522.44 plus fuel costs. The 2012 contract was for \$101,492.58 plus fuel costs.

Resolution 12-11-145 This resolution approves an agreement between the Township and DPL Energy to be the preferred provider of electricity within the DP & L service area. If Township residents select DPL Energy to be their electric supplier, they will receive the rate of .0625¢/kwh, which is .0025¢/kwh better than their advertised a rate.

This is at no cost or obligation to the Township or its residents. This agreement does not have any effect on the service area of Pioneer Electric.

Resolution 12-11-146 This resolution approves the service agreement for our heart monitors on both Medic 1 and 2. This is a three year contract.

Resolution 12-11-147 This resolution approves the annual membership pass for the Township to Aileron at \$1,000.00. There was no increase again this year for this.

Resolution 12-11-148 This resolution accepts Matt's resignation from the Fire Department.

Resolution 12-11-149 This resolution appoints Kyle Blankenship to the Fire Department as a Paramedic/Firefighter. He will be assigned to the Sunday night crew.

WHEREAS, THE BOARD OF TRUSTEES OF BETHEL TOWNSHIP, MIAMI COUNTY AND THE SHERIFF OF MIAMI COUNTY HAVE ENTERED INTO AGREEMENTS IN THE PAST WHICH PROVIDE FOR ADDITIONAL POLICE PROTECTION FOR THE RESIDENTS OF BETHEL TOWNSHIP IN ACCORDANCE WITH SECTION 505.43 OF THE OHIO REVISED CODE, AND

WHEREAS, THE BOARD OF TRUSTEES OF BETHEL TOWNSHIP, MIAMI COUNTY ADOPTED RESOLUTION #11-11-140 TO ENTER INTO AN AGREEMENT WITH THE MIAMI COUNTY SHERIFF TO PROVIDE POLICE PROTECTION FOR 2012, AND

WHEREAS, THE BOARD OF TRUSTEES OF BETHEL TOWNSHIP, MIAMI COUNTY ARE PERMITTED THROUGH SECTION 505.43 OF THE OHIO REVISED CODE TO CONTRACT FOR POLICE SERVICES FROM A COUNTY SHERIFF ,AND

A RESOLUTION ENTERING INTO AN AGREEMENT AT NO COST OR OBLIGATION TO BETHEL TOWNSHIP OR ITS RESIDENTS WITH DPL ENERGY RESOURCES INC. TO BE THE TOWNSHIPS PREFERRED ENERGY PROVIDER IN EXCHANGE FOR OFFERING A DISCOUNTED PRICE OVER AND ABOVE THEIR CURRENT ADVERTISED RATE

WHEREAS, DPLER is a Competitive Retail Electric Service (“CRES”) Provider certified by the Public Utilities Commission of Ohio (“PUCO”) to sell competitive retail electric service to customers in the State of Ohio utilizing existing transmission and distribution systems; and

WHEREAS, DPLER desires to provide an offer to sell competitive retail electric services to inhabitants of the Bethel Township, Miami County; and

WHEREAS, Bethel Township desires to establish an affinity program with DPLER whereby DPLER will offer certain competitive retail electric services to the Township’s residents at a discounted price in exchange for the right to be the Township’s preferred energy provider (the “Affinity Program”); and

WHEREAS, although DPLER is a CRES provider with the ability to provide government aggregation services, Bethel Township and DPLER expressly acknowledge that this is not a government aggregation program and that DPLER is not designated as an exclusive provider of competitive retail electric services within Bethel Township by their entry into this Affinity Agreement THEREFORE,

BE IT RESOLVED BY THE BOARD OF TRUSTEES OF BETHEL TOWNSHIP, MIAMI COUNTY THAT:

- SECTION 1: THE BOARD WELCOMES THE OPPORTUNITY TO PROVIDE RESIDENTS WITHIN THE DP&L SERVICE AREA OF THE TOWNSHIP THE OPPORTUNITY TO RECEIVE A LOWER KW/H ENERGY PRICE THAN AVAILABLE THROUGH ADVERTISED PRICING.
- SECTION 2: BETHEL TOWNSHIP SELECTS DPL ENERGY AS THE PREFERRED ENERGY PROVIDER FOR ONLY THE PORTION OF BETHEL TOWNSHIP THAT THEY CAN SERVICE.
- SECTION 3: BETHEL TOWNSHIP'S SELECTION OF DPL ENERGY AS THE PREFERRED ENGERY PROVIDER DOES NOT EFFECT ANY PROPERTIES WITHIN THE PIONEER ELECTRIC SERVICE AREA.
- SECTION 4: BETHEL TOWNSHIP VALUES ITS RELATIONSHIP WITH PIONEER ELECTRIC.
- SECTION 5: AUTHORIZES THE TOWNSHIP ADMINISTRATOR TO EXECUTE ALL NECESSARY DOCUMENTS ON BEHALF OF THE BOARD OF TRUSTEES FOR THIS AGREEMENT
